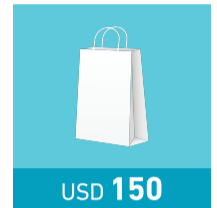

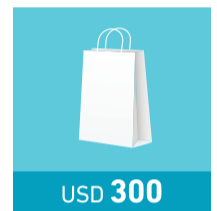

Example of exemption when travelling by air

Compra Purchase	USD 400
Franquicia Exemption	USD 300
Exceso Exceeding amount	USD 100
Arancel Duty	USD 50

Arancel igual al 50% del total excedido
Duty equal to the 50% of the total exceeded amount

Menores de 16 años: franquicias al 50%
Padres e hijos pueden usar las franquicias en forma conjunta.

Children under 16 years of age: 50% exemption.
Parents and their children can join their exemptions.

Ingreso y egreso de valores

Transportation of currency

Ingreso / Entry

Permitido el ingreso de sumas inferiores a USD 10.000 o su equivalente en otra moneda. Montos superiores: declaración en Aduana (OM 2249A).
The amounts that can be brought into the country shall be lower than USD 10,000 or its equivalent in other currency. Amounts above USD 10,000: Customs Declaration (OM 2249A).

Egreso / Exit

Permitido el egreso de sumas inferiores a USD 10.000. Montos superiores: solo en pesos, declárandolos en Aduana (OM 2250B).
The amounts that can leave the country shall be lower than USD 10,000. Amounts above USD 10,000: only in Argentine Pesos including the Customs Declaration (OM 2250B).



Menores de 16 años: USD 5.000
Children under the 16 years of age: USD 5,000

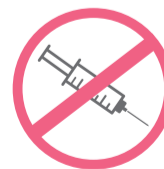
